

RESOLUTION NO. 219981

WHEREAS, in approving the final map of TOPEKA VALE UNIT NO. 1 subdivision, the City shall receive easement interests which allow the relocation of existing storm drains within the areas of the subdivision; and

WHEREAS, to allow the efficient use of the property within the subdivision, it is necessary and desirable to quitclaim the City's existing drainage easements within the subdivision in exchange for those easements to be acquired at the time the subdivision map is approved; and

WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 762282, quitclaiming to T.F.L. COMPANY, a partnership, by TIME FOR LIVING, INC., a California corporation, all the City's right, title and interest in the drainage easements, as more particularly described in said form of quitclaim deed.
