

RESOLUTION NO. 219982

WHEREAS, a slope easement was acquired for an earlier development in the area now within the subdivision known as TOPEKA VALE UNIT NO. 1; and

WHEREAS, the present development of the property proposes grading which will remove the need for the slope easement; and

WHEREAS, this aforementioned easement has never served the purpose for which it was originally acquired; and

WHEREAS, the easement will conflict with the development of TOPEKA VALE UNIT NO. 1; and

WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City of San Diego by this resolution does hereby abandon whatever right, title or interest it may have in the slope easement, as more particularly shown on Drawing No. 14166-B on file in the office of the City Clerk as Document No. 762286, which is by this reference incorporated herein and made a part hereof.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal to be recorded in the office of the County Recorder.
