WHEREAS, the present development of the property conflicts with the existing slope easement; and

WHEREAS, the aforementioned slope easement has never been used for the purpose of which it was originally acquired; and

WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City of San Diego, by this resolution, does hereby abandon whatever right, title or interest it may have in the slope easement, as more particularly shown on Drawing No. 14174-B on file in the office of the City Clerk as Document No. 762248, which is by this reference incorporated herein and made a part hereof.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
