RESOLUTION NO. 219993

WHEREAS, the Law Enforcement Assistance Administration (LEAA) may consent to review for possible funding the project submitted by The City of San Diego referred to as "Law Enforcement Focus on Career Criminal," on file in the office of the City Clerk as Document No. 762231; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized, for and on behalf of said City, to submit to the Law Enforcement Assistance Administration (LEAA) the application for grant for law enforcement purposes.

2. That in the event the LEAA consents to fund the above project from funds made available through the Omnibus Crime Control and Safe Streets Act, The City of San Diego agrees to accept the grant and designates the City Manager to execute, for and on behalf of said City, the contract for the grant for law enforcement purposes, including any extensions or amendments thereof, that do not require any additional appropriation of cash match.

3. That the City of San Diego agrees to provide the required matching funds to said project (including any extension or amendments thereof) under the Safe Streets Act and the LEAA and that cash will be appropriated as required thereby.



4. That grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.

5. That the City Manager is authorized without further Council action to go to bid (when necessary) and to execute contracts for the consultant services, leases, purchases, and all other related contracts and agreements specified in the grant contract.

6. That \$33,333 of City funds appropriated in the City's Fiscal Year 1978 Budget for the purpose of the required cash match specified in the grant contract is hereby authorized to be expended.


