BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO to enforce animal regulation ordinances on City beaches and beach parks, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 762205.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer \$56,500 from General Fund 100 (Unallocated Reserve 53.31) to General Fund 100 (Element 44.01 - Animal Regulation Services) in an amount of \$43,800 and General Fund 100 (Element 88.50 - Motive Fleet Purchase) in an amount of \$12,700, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for animal regulation enforcement and to purchase the necessary motive and communication equipment.
