The base of measurement of the height shall be in accordance with the Uniform Building Code of 1970.

Notwithstanding any section to the contrary, there shall be no exception to the provisions of this section.


This section shall remain in force and effect until

AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 4 OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 101.041 RELATING TO THE LIMITATION OF HEIGHT OF BUILDINGS IN THE COASTAL ZONE.

BE IT ORDAINED by the Council of The City of San Diego as follows:

Section 1. That Chapter X, Article 1, Division 4 of the San Diego Municipal Code be amended by adding Section 101.041 to read as follows:

SECTION 101.041. LIMITATION OF HEIGHT OF BUILDINGS IN THE COASTAL ZONE.

Notwithstanding any section to the contrary, no building or addition to a building shall be constructed with a height in excess of 90 feet within the Coastal Zone of the City of San Diego, as shown on Drawing No. C-380, on file in the office of the City Clerk as Document No. 743737.

The words "Coastal Zone" as used within this section shall mean that land and water area of The City of San Diego from the northern City limits south to the border of the Republic of Mexico, extending seaward to the outer limits of City jurisdiction and extending inland to the location of Interstate 5 on January 1, 1971. This limitation shall not apply to the land area of the Coastal Zone bounded by National City on the south, San Diego Bay on the west and Laurel Street or the southwesterly projection of Laurel Street on the north.

The base of measurement of the height shall be in accordance with the Uniform Building Code of 1970.

Notwithstanding any section to the contrary there shall be no exception to the provisions of this section.

This section shall remain in force and effect until July 12, 1974.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
