ORDINANCE NO. 123

AN ORDINANCE INCORPORATING LOTS 3 AND 4, LODI PLAZA (APPROXIMATELY 1.94 ACRES), LOCATED ON THE SOUTH SIDE OF LOGAN AVENUE BETWEEN EUCLID AVENUE AND 49TH STREET, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8295 (NEW SERIES), ADOPTED MAY 19, 1960, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 3 and 4, Lodi Plaza (approximately 1.94 acres), located on the south side of Logan Avenue between Euclid Avenue and 49th Street, in the Southeast San Diego Community Plan Area, in the City of San Diego, California; within the boundary of the district designated ""R-3" on Zone Map Drawing B-3039, filed in the office of the City Clerk as Document No. 761993, be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 8295 (New Series), adopted May 19, 1960, of the ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and
