AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 8766, (NEW SERIES), ADOPTED DECEMBER 13, 1962, AMENDED BY ORDINANCE NO. 11411 (NEW SERIES), ADOPTED OCTOBER 17, 1974, AMENDED BY ORDINANCE NO. 11974 (NEW SERIES), ADOPTED DECEMBER 29, 1976, INCORPORATING A PORTION OF RANCHO SAN BERNARDO, RECORD OF SURVEY 6081, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA-S ZONE, AS DEFINED BY SECTION 101.0428 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 8766 (New Series), adopted December 13, 1962; and

WHEREAS, Section 1 of Ordinance No. 8766 (New Series)
provided that the CA-S Zone would attach if a final subdivision
map or maps were recorded on or before November 16, 1976; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 8766 (New Series), adopted December 13, 1962, amended by Ordinance No. 11411 (New Series), adopted October 17, 1974, amended by Ordinance No. 11974 (New Series), adopted December 29, 1976, be, and it is hereby amended to read as follows:

thereof duly submitted to the City on or before
November 16, 1978, and thereafter recorded, and within
such subdivision or subdivisions provision is made
for the installation of public utility services and
the dedication of streets, alleys and easements for
public use, the provisions of Section 101.0428 shall
attach and become applicable to the said subdivided
land and the said subdivided land shall be incorporated
into CA-S Zone, as described by Section 101.0428 of
the San Diego Municipal Code, the boundary of such zone
to be as indicated on Zone Map Drawing No. B-2803, filed
in the office of the City Clerk as Document No. 747575.
Said zoning shall attach only to those areas included
in the subdivision map or maps recorded as provided in
this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
