ORDINANCE NO. 12260

(New Series)

AN ORDINANCE AMENDING ORDINANCE NO. 12135 (NEW SERIES, AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1977-78 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 75895, AS ADOPTED AND AMENDED BY DOCUMENT NOS. 760516 AND 761079, RELATING TO PERSONNEL, EQUIPMENT AND FUNDING THEREFOR WITHIN GENERAL FUND 100, CITY ATTORNEY'S DEPARTMENT 0930, AUTHORIZING AND DIRECTING THE CITY AUDITOR AND COMPTROLLER TO TRANSFER WITHIN THE GENERAL FUND THE SUM OF \$24,886 FROM THE UNALLOCATED RESERVE (\$3,400 TO THE ABOVE DEPARTMENT FOR ADDITIONAL PERSONNEL, NON-PERSONAL EXPENSE AND EQUIPMENT.

WHEREAS the Board of Administration of the City Employees Retirement System at its meeting of November 23, 1977 adopted a procedure for utilizing a Board Adjudicator (Hearing Officer) in connection with applications for industrial disability retirement; and

WHEREAS the Rules Committee at its meeting of November 28, 1977 approved the implementation of the adjudicator proposal; and

WHEREAS the implementation of the adjudicator proposal will require the addition of one Deputy City Attorney, one Legal Stenographer, and related equipment and non-personal expense to the City Attorney's Department in the amount of \$24,886 for the period January 1, 1978 through June 30, 1978; NOW THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Ordinance No. 12135 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1977-78 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending the fiscal allocations and personnel authorization for Department Activity 0930 to include the transfer of the sum of \$24,886 from the General Fund Unallocated Reserve (\$3,400) to the said department for personal services, nonpersonal services and equipment outlay in accordance with the proposed budget allocation attached hereto as Attachment A.

Section 2. That Ordinance No. 12135 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1977-78 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended to amend that portion of the Position and Salary Schedule for the City Attorney's Department 0930, to reflect and authorize the addition of one Deputy City Attorney and one Legal Stenographer.

Section 3. That the City Auditor and Comptroller be and he is hereby fully authorized and directed to transfer within the General Fund 100 the sum of \$24,886 from the Unallocated Reserve (\$3,400) to the above mentioned department and activities for personal services, nonpersonal services and equipment outlay in accordance with the proposed budgetary allocation attached hereto as Attachment A.

Section 4. This ordinance shall take effect and be in force on the third day from and after its adoption.
