ORDINANCE NO. 12261 (New Series)

AN ORDINANCE RESCINDING ORDINANCE NO. 12013 (NEW SERIES) RELATING TO THE ESTABLISHMENT OF THE POSITION OF LEGISLATIVE ANALYST AND ORDINANCE NO. 12014 (NEW SERIES) RELATING TO THE ALLOCATION OF PERSONNEL AND FUNDS FOR THAT FUNCTION.

WHEREAS, the Council introduced Ordinance No. 12013 (New Series) on February 2, 1977, amending the salary ordinance to establish the position of Legislative Analyst; and

WHEREAS, the Council concurrently introduced Ordinance
No. 12014 (New Series) on that date to amend the budget for
the purpose of allocating funds for the payment of the Legislative Analyst function and related personnel; and

WHEREAS, said ordinances were challenged in court as being in conflict with the provisions of the Charter; and

WHEREAS, the Superior Court for the State of California in the County of San Diego ruled in Case No. 358163 by judgment entered on September 12, 1977, that the action did, in fact, violate the Charter of The City of San Diego; and

WHEREAS, the court further ordered that said ordinances be rescinded; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12013 (New Series) relating to the establishment of the position of Legislative Analyst and Ordinance No. 12014 (New Series) relating to the allocation

of funds for that function and related personnel be, and they are hereby rescinded.

Section 2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100 the sum of \$129,247 from the Legislative Analyst Program Element 02.12 to the Unallocated Reserve 53.30.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
