ORDINANCE NO. 12264 (New Series)

AN ORDINANCE INCORPORATING LOT 11, GRACE MANOR, (APPROXIAMATELY 2.26 ACRES), LOCATED ON THE SOUTH SIDE OF BEAGLE STREET AND EAST OF ATLAS STREET, IN THE CLAIREMONT MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Lot 11, Grace Manor (approximately 2.26 acres), located on the south side of Beagle Street and east of Atlas Street, in the Clairemont Mesa Community Plan area, in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. B-3010.1, filed in the office of the City Clerkas Document No. 762959 be, and it is hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13457, adopted February 15, 1932, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
