AN ORDINANCE AMENDING CHAPTER V, ARTICLE 6,
OF THE SAN DIEGO MUNICIPAL CODE BY ADDING
SECTION 56.55 PROHIBITING URINATING/DE-
FECATING IN PUBLIC.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter V, Article 6, of the San Diego
Municipal Code be and the same is hereby amended by adding
Section 56.55 to read as follows:

SEC. 56.55 URINATING/DEFECATING IN PUBLIC PROHIBITED

No person shall urinate or defecate in or upon
any street, sidewalk, alley, plaza, park, beach,
public building or publicly maintained facility,
or in any place open to the public or exposed to
public view. This section shall not apply to urina-
tion or defecation which is done in any restroom or
other facility designed for the sanitary disposal
of human waste.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
