AN ORDINANCE AMENDING CHAPTER II,
ARTICLE 2, DIVISION 1, OF THE SAN
DIEGO MUNICIPAL CODE BY AMENDING
RULE 29 TO SECTION 22.0101 RELATING
TO DELIVERY OF RESOLUTION OR ORDI-
NANCE TO RULES COMMITTEE.

BE IT ORDAINED, by the Council of The City of San
Diego, as follows:

Section 1. That Chapter II, Article 2, Division 1, of
the San Diego Municipal Code be amended by amending Rule 29
to Section 22.0101 to read as follows:

Rule 29. Delivery of Resolution or Ordinance to
Rules Committee

The official who signed the form 1472 shall cause
the resolution or ordinance, with attached digest, pre-
pared in accordance with Rule 28, to be delivered to
the Rules Committee no later than 5:00 p.m. on Thursday
for listing on the docket of the regular Council meetings
to be held during the week following the next succeeding
week or, at the discretion of the Rules Committee, the
week thereafter.

Ordinances or resolutions that are reported out of
committee in accordance with Rule 17 shall be delivered
to the Rules Committee by the committee chairman by
5:00 p.m. on Thursday for listing on the docket of the
regular Council meetings to be held during the week
following the next succeeding week or, at the discretion
