AN ORDINANCE INCORPORATING 48.8 ACRES OF M-1 ZONED PROPERTY GENERALLY LOCATED BETWEEN PACIFIC HIGHWAY AND I-5, NORTHERLY OF WITHERBY STREET, IN THE MIDWAY COMMUNITY PLANNING AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12990, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 48.8 acres of M-l zoned property generally located between Pacific Highway and I-5, northerly of Witherby Street, in the Midway Community Planning Area, in the City of San Diego, California, within the boundary of the district designated "M-lB" on Zone Map Drawing C-516.2, be, and it is hereby incorporated into M-lB Zone, as such zone is described and defined by Section 101.0435.2 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12990, approved October 20, 1930, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
