AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING DIVISION 25 PROVIDING FOR A SECRETARY OF THE CITY COUNCIL FOR CLAIMS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, of the San Diego Municipal Code is hereby amended by adding Division 25, Sections 22.2501, 22.2502 and 22.2503, to read as follows:

SEC. 22.2501 DESIGNATION OF DIRECTOR OF RISK MANAGEMENT AS SECRETARY OF COUNCIL FOR CLAIMS

The Director of Risk Management is hereby appointed as Secretary of the City Council for the purpose of receiving and processing all claims filed against The City of San Diego pursuant to Section 915 of the California Government Code.

SEC. 22.2502 CLAIMS TO BE FORWARDED TO DIRECTOR OF RISK MANAGEMENT

Any department of the City which hereafter receives a claim by personal delivery, mail or otherwise shall forthwith forward the claim to the Director of Risk Management for processing.

SEC. 22.2503 DIRECTOR OF RISK MANAGEMENT--ADDITIONAL RESPONSIBILITY

The Director of Risk Management, as Secretary of the City Council for Claims, shall assume the responsibility for keeping current that information concerning The City of San Diego contained in the statement in the

Roster of Public Agencies which is filed in the Office of the Secretary of State or in the Office of the County Clerk of San Diego and to which persons desiring to file claims are referred by Section 915(d) of the California Government Code.

Section 2. This ordinance shall take effect and be in force from the thirtieth day from and after its passage.


