AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 4, DIVISIONS 16 AND 17 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 84.1603, 84.1604, 84.1703 AND 84.1704 RELATING TO THE RANCHO BERNARDO AND RANCHO PENASQUITOS GOLF CART ZONES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Sections 84.1603, 84.1604, 84.1703 and 84.1704 of Chapter VIII, Article 4, Divisions 16 and 17 of the San Diego Municipal Code be and they are hereby amended to read as follows:

SEC. 84.1603 DEFINITIONS

Whenever used in this division, the following words or phrases shall mean:

- (a) "City" shall mean The City of San Diego, a municipal corporation in the State of California.
- (b) "City Manager" shall mean the City Manager as that office is defined in Section 27 of the City Charter and any officer or employee of City, appointed by the City Manager to act for him.
- (c) "Golf cart" shall mean a motor vehicle having not less than three wheels in contact with the ground, having an unladen weight less than one thousand three hundred (1300) pounds, which is designed to be and is operated at not more than fifteen miles per hour (15 m.p.h.) and designed to carry golf equipment and not more than two persons including the driver.

(d) "Golf Cart Zone" shall mean that area within one (1) mile of the boundaries of the Rancho Bernardo Golf Courses as determined by the City Manager.

- C. "Golf Cart" shall mean a motor vehicle having not less than three wheels in contact with the ground, having an unladen weight less than one thousand three hundred (1300)

pounds which is designed to be and is operated at not more than fifteen miles per hour (15 m.p.h.) and designed to carry golf equipment and not more than two persons including the driver.

D. "Golf Cart Zone" shall mean that area within one (1) mile of the boundaries of the Rancho Penasquitos Golf Courses as determined by the City Manager.

SEC. 84.1704 ESTABLISHMENT OF GOLF CART ZONE

  Courses within which unregistered golf carts may be operated
  except that:

- C. The City Manager's designation of the limits of the Golf Cart Zone and excepted streets shall be conclusive.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
