AN ORDINANCE INCORPORATING A PORTION OF LOT 78, RANCHO MISSION REFEREE'S PARTITION, S.C.C. NO. 162892 (APPROXIMATELY 4.97 ACRES), LOCATED ON THE NORTH SIDE OF KEARNY MESA ROAD AND WEST OF MAGNATRON BOULEVARD, IN THE SERRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CR ZONE, AS DEFINED BY SECTION 101.0421.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 6714 (NEW SERIES), ADOPTED OCTOBER 13, 1955, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That a portion of Lot 78, Rancho Mission Referee's Partition, S.C.C. No. 162892 (approximately 4.97 acres), located on the north side of Kearny Mesa Road and west of Magnatron Boulevard, in the Serra Mesa Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "CR" on Zone Map Drawing B-3061, be, and it is hereby incorporated into CR Zone, as such zone is described and defined by Section 101.0421.1 of the San Diego Municipal Code, subject to the Engineering and Development Director's requirements for the payment of park fees.


Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 6714 (New Series), adopted October 13, 1955, of the ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and
