AN ORDINANCE INCORPORATING LOTS 1-3, 12-15, and 17, BLOCK F, OAK PARK ADDITION, MAP NO. 1732 AND LOT 8, OAK PARK ANNEXATION, MAP NO. 1764 (APPROXIMATELY 2.9 ACRES), LOCATED ON THE SOUTH SIDE OF UNIVERSITY AVENUE BETWEEN 50TH STREET AND 52ND STREET, IN THE MID-CITY DEVELOPMENT PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 184 (NEW SERIES), ADOPTED MARCH 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 1-3, 12-15, and 17, Block F, Oak
Park Addition, Map No. 1732 and Lot 8, Oak Park Annexation,
Map No. 1764 (approximately 2.9 acres), located on the south
side of University Avenue between 50th Street and 52nd Street,
in the Mid-City Development Plan Area, in the City of San Diego,
California, within the boundary of the district designated
"R-3" on Zone Map Drawing No. B-3070, filed in the office of
the City Clerk as Document No. 762779, be, and it is hereby
incorporated into R-3 Zone, as such zone is described and
defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 184 (New Series), adopted March 3, 1933, of the ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
