AN ORDINANCE INCORPORATING LOT 3082, CLAIREMONT UNIT NO. 15, MAP NO. 3008 (APPROXIMATELY 6,000 SQUARE FEET), LOCATED ON THE SOUTH SIDE OF CLAIREMONT MESA BOULEVARD BETWEEN POCAHONTAS AVENUE AND CLAIREMONT DRIVE, IN THE CLAIREMONT MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11262 (NEW SERIES), ADOPTED FEBRUARY 28, 1974, OF THE CORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 3082, Clairemont Unit No. 15, Map
No. 3008 (approximately 6,200 square feet), located on the south
side of Clairemont Mesa Boulevard between Pocahontas Avenue
and Clairemont Drive, in the Clairemont Mesa Community Plan Area,
in the City of San Diego, California, within the boundary of
the district designated "CO" on Zone Map Drawing No. B-3074,
filed in the office of the City Clerk as Document No. 762746,
be, and it is hereby incorporated into CO Zone, as such zone
is described and defined by Section 101.0423 of the San Diego
Municipal Code.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 11262 (New Series), adopted February 28, 1974, of the ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
