EXISTING LEASE AGREEMENTS AND PERMITS


BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That with regard to City leases and  
permits to the Lessees and Permittees, as described in  
Council Resolution No. 220451, the requirements of  
subsection (c) of Municipal Code Section 22.0901 pertaining  
to the necessity for a fee appraisal are hereby waived.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
