AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 11272 (NEW SERIES), ADOPTED MARCH 28, 1974, AMENDED BY ORDINANCE NO. 11857 (NEW SERIES), ADOPTED JUNE 30, 1976, INCORPORATING A PORTION OF THE NORTHEAST 1/4, SECTION 1, TOWNSHIP 19 SOUTH, RANGE 2 WEST, SBBM. AND A PORTION OF THE NORTHWEST 1/4, SECTION 6, TOWNSHIP 19 SOUTH, RANGE 1 WEST, SBBM, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE, AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. 11272 (New Series), adopted March 28, 1974; and

WHEREAS, Section 1 of Ordinance No. 11272 (New Series) provided that the M-1B Zone would attach if a final subdivision map or maps were recorded on or before April 27, 1976; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 11272 (New Series), adopted March 28, 1974, amended by Ordinance No. 11857 (New Series), adopted June 30, 1976, be, and it is hereby amended to read as follows:

Section 1. That in the event that a portion of the Northeast 1/4, Section 1, Township 19 South, Range 2 West, SBBM, and a portion of the Northwest 1/4, Section 6, Township 19 South, Range 1 West, SBBM,



in the City of San Diego, designated "M-1B" on Zone Map Drawing No. B-2675.1, is subdivided and a final subdivision map or maps thereof duly submitted to the City on or before April 27, 1980, and within such subdivision provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0435.2 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into M-1B Zone, as described by Section 101.0435.2 of the San Diego Municipal Code, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2675.1, filed in the office of the City Clerk as Document No. 746451.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
