AN ORDINANCE AMENDING ORDINANCE NO. 12078 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1977-1978," BY AMENDING EXHIBITS A AND B THERETO TO CREATE THE CLASSIFIED POSITIONS OF ASSISTANT ECONOMIST, SUPERVISING ECONOMIST, DEPUTY NOISE ABATEMENT OFFICER, SPECIAL TRANSPORTATION SUPERINTENDENT, DISPOSAL SITE SUPERVISOR, COMMUNITY PROGRAM SPECIALIST I, COMMUNITY PROGRAM SPECIALIST II, COMMUNITY PROGRAM SPECIALIST III, AND COMMUNITY PROGRAM ADMINISTRATOR, AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 12078 (New Series), as amended, entitled, "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1977-78," is hereby amended to create and establish the classified positions of Assistant Economist, Supervising Economist, Deputy Noise Abatement Officer, Special Transportation Superintendent, Disposal Site Supervisor, Community Program Specialist I, Community Program Specialist II, Community Program Specialist III, and Community Program Administrator.

Section 2. As a schedule of compensation for the positions created in Section 1 hereof, the following standard rate numbers of the Table of Pay for Standard Rates established and adopted by Ordinance No. 12078 (New Series), as amended, of the ordinances of said City, is hereby adopted.


