ORDINANCE NO. 12336

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 1, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 21.04 RELATING TO HOLIDAYS.

WHEREAS, in 1970, the City Council designated the fourth Monday in October as Veterans' Day in conformance with the federal "Monday Holiday Bill"; and

WHEREAS, the federal government, as well as the State of California, San Diego County and local school districts have reverted to observing "Veterans' Day" on November 11; and

WHEREAS, the current municipal code does not provide for an alternative day to celebrate holidays falling on a Saturday; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 1, of the San Diego Municipal Code be and is hereby amended by amending Section 21.04 to read as follows:

SEC. 21.04 HOLIDAYS

Except where otherwise specifically defined and provided in this Code, the holidays in The City of _ San Diego are:

- (a) January 1st;
- (b) Third Monday in February, known as "Washington's Birthday";
 - (c) Last Monday in May, known as "Memorial Day";
 - (d) July 4th;

- (e) First Monday in September, known as "Labor Day";
- (f) Second Monday in October, known as "Columbus Day";
 - (g) November 11th, known as "Veterans' Day";
 - (h) December 25th; and
- (i) Every day appointed by the President, Governor, or the City Council for a public fast, thanksgiving or holiday.

If January 1st, July 4th, November 11th or December 25th fall upon a Sunday, the Monday following is a holiday, and if they fall on a Saturday, the preceding Friday is a holiday.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
