AN ORDINANCE INCORPORATING 114 ACRES OF M-1A ZONED PROPERTY GENERALLY BOUNDED ON THE NORTHWEST BY STATE ROUTE 163, ON THE EAST BY I-15 AND ON THE SOUTH BY THE CENTER LINE OF PROPOSED STATE ROUTE 52, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-10 ZONE, AS DEFINED BY SECTION 101.0404 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 6021 (NEW SERIES), ADOPTED MARCH 18, 1954, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS IT CONFLICTS HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That 114 acres of M-1A zoned property generally bounded on the northwest by State Route 163, on the east by I-15 and on the south by the center line of proposed State Route 52, in the City of San Diego, California, within the boundary of the district designated "A-1-10" on Zone Map Drawing No.C-608.2, be, and it is hereby incorporated into A-1-10 Zone, as such zone is described and defined by Section 101.0404 of the San Diego Municipal Code.

Section 2. That Ordinance No. 6021 (New Series), adopted March 18, 1954, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
