TANNER/SAMPO ANNEXATIONS INTO COUNCIL DISTRICT 7



BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That the area designated as HOWARD DWORKIN ANNEXATION, and the area designated as TANNER/SAMPO ANNEXATION, which areas were annexed to the City of San Diego by Resolution Nos. 219606 and 219607, respectively, adopted November 2, 1977, are hereby added to Council District No. 7, which district is shown and delineated on that certain map on file in the office of the City Clerk as Document No. 742458, showing the boundary line of said district, and which map was approved by Ordinance No. 10990 (New Series) of the ordinances of The City of San Diego, adopted February 6, 1973.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


