
AN ORDINANCE INCORPORATING THAT PORTION OF THE MURPHY CANYON ANNEXATION WEST OF INTERSTATE HIGHWAY 15 INTO COUNCIL DISTRICT 5, AND INCORPORATING THAT PORTION OF MURPHY CANYON ANNEXATION EAST OF INTERSTATE HIGHWAY 15 INTO COUNCIL DISTRICT 7.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the areas designated as MURPHY CANYON ANNEXATION west of Interstate 15, and MURPHY CANYON ANNEXATION east of Interstate Highway 15, which areas were annexed to the City of San Diego by Resolution Minute Order No. 17, adopted by the Board of Supervisors of the County of San Diego on June 15, 1977, are hereby added to Council District 5 and Council District 7, respectively, which districts are shown and delineated on that certain map on file in the office of the City Clerk as Document No. 742458, showing the boundary lines of said districts, and which districts were defined and which map was approved by Ordinance No. 10990 (New Series) of the ordinances of The City of San Diego, adopted February 6, 1973.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

That the areas designated as MURPHY CANYON ANNEXATION west of Interstate 15, and MURPHY CANYON ANNEXATION east of Interstate Highway 15, which areas were annexed to the City of San Diego by Resolution Minute Order No. 27, adopted by the Board of Supervisors of the County of San Diego on June 15, 1977, are hereby added to Council District 5 and Council District 7, respectively, which districts are shown and delineated on that certain map on file in the office of the City Clerk as Document No. 743488, showing the boundary lines of said districts, and which districts were defined and which map was approved by Ordinance No. 10880 (New Series) of the ordinances of The City of San Diego, adopted February 6, 1973.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


