AN ORDINANCE INCORPORATING PORTIONS OF LOTS A-203 AND A-204, LITTLE LANDERS ADDITION NO. 3; A PORTION OF SECTION 2, TOWNSHIP 19 SOUTH, RANGE 2 WEST, AND A PORTION OF SECTION 35, TOWNSHIP 18 SOUTH, RANGE 3 WEST, S.B.B.M., IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428.1 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance portions of Lots A-203 and A-203, Little Landers Addition No. 3; a portion of Section 2, Township 19 South, Range 2 West; and a portion of Section 35, Township 18 South, Range 3 West, S.B.B.M., in the City of San Diego, California, designated "CA" on Zone Map Drawing No. B-3087.1, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys, and easements for public use, the provisions of Section 101.0428.1 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into CA Zone, as described and defined by Section 101.0428.1, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3087.1, filed in the office of the City Clerk as Document No. 763425. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 8028 (New Series), adopted December 19, 1958, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.

ORDINANCE NO. 12363

AN ORDINANCE AMERICANO CHAPTER II, ARTICLE 2, DIVISION 2 OF THE SAN DISCO MUNICIPAL CODE BY ADDRESS SECTIONS 22.0210, 22.0210.1 AND 22.0210.2 RELATING TO PUBLIC WORKS CONTRACTS.

RE IT GRDAINED, by the Council of the City of San Diego, as

follows:
Section 1. That Chapter II. Article 2, Invision 2 of the Sen Diago

SEC. 22,0210 PUBLIC WORKS CONTRACTS—PURPOSE AND INTENT

Section 94 of the Charter of The City of San Diego was assembled at the election of September 20, 1977 to permit the Council to set by ordinance the minimum sonerary limits above which public owrits contracts are required to be let to the lowest responsible and reliable bidder following advertising for sealed proposals therefor. The said Section 94 was also amended to permit the Council to establish by ardinance an amount below which the City Manager may order the performance of any construction, reconstruction or repair work by appropriate City Incres without Enst obtaining Council approved. The subsections that follow are ensired for the purpose of implementage the foregoing amendment to the Charter.

SEC. 22,0210.1 SAME—ATVERTISING—MINIMUM MONETARY LIMIT

In the construction, reconstruction or repair of public buildings, stream, utilities and other public works when the expanditure therefor shall exceed the sum of \$10,000, the same shall be done by written contract and advertising for bids inder the provisions of Section 94 of the City Charter.
