AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 4 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 64.32 RELATING TO SEWER SERVICE CHARGES.

JUN 5 1978

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 4, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 64.32 to read as follows:

SEC. 64.32 SEWER SERVICE CHARGE ESTABLISHED

In addition to other fees, assessments or charges provided by the Municipal Code, the owner or occupant of any parcel of real property for which no other sewer service charge is provided, and which parcel of property is connected with the sewer system and/or water system of the City of San Diego, shall pay a sewer service charge as follows:

- (1) The domestic sewer service charge for each single family dwelling unit serviced by a separate water meter shall be three dollars (\$3.00) per month.
- (2) The monthly sewer service charge for all premises, other than single family dwelling unit serviced by a separate water meter, shall be at the rate of twenty-one and three-tenths cents (\$0.213) per one hundred cubic feet of water usage by such premise, but in no case less than a minimum charge of three dollars (\$3.00) per month.
