ORDINANCE NO. (New Series)

AN ORDINANCE INCORPORATING A PORTION OF RANCHO SAN BERNARDO, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5, R-2, R-2A, AND CN ZONES AS DEFINED BY SECTIONS 101.0407, 101.0409, 101.0410, AND 101.0426, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8782 (NEW SERIES), ADOPTED JANUARY 31, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance a portion of Rancho San . Bernardo, in the City of San Diego, California, designated "R-1-5," "R-2," R-2A," and "CN" on Zone Map Drawing No. B-3082, is subdivided and a subdivision map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Sections 101.0407, 101.0409, 101.0410, and 101.0426 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into R-1-5, R-2, R-2A, and CN Zones, as described and defined by Sections 101.0407, 101.0409, 101.0410, and 101.0426, respectively, the boundary of such zones to be as indicated on Zone Map Drawing No. B-3082, filed in the office of the City Clerk as Document No. 763324. Said zoning shall attach only to those areas included in the map as provided in this section.



Section 2. That Ordinance No. 8782 (New Series), adopted January 31, 1962, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.

AN ORDINANCE INCORPORATING A PORTION OF RANCHO SAN BERNARDO (APPROXIMATELY 79.06 ACRES), LOCATED ON THE SOUTH SIDE OF WEST BERNARDO DRIVE AND EAST OF THE SOUTHERLY EXTENSION OF BERNARDO CENTER DRIVE, IN THE RANCHO BERNARDO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5, R-2, R-2A AND CN ZONES AS DEFINED BY SECTIONS 101.0407, 101.0409, 101.0410 AND 101.0426, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8782 (NEW SERIES), ADOPTED JANUARY 31, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Rancho San Bernardo (approximately 79.06 acres), located on the south side of West Bernardo Drive and east of the southerly extension of Bernardo Center Drive, in the Rancho Bernardo Community Plan Area, in the City of San Diego, California, within the boundary of the district designated. "R-1-5," "R-2," "R-2A" and "CN" on Zone Map Drawing No. B-3082, filed in the office of the City Clerk as Document No. 763324, be, and it is hereby incorporated into the R-1-5, R-2, R-2A and CN Zones, as such zones are described and defined by Sections 101.0407, 101.0409, 101.0410 and 101.0426, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 8782 (New Series), adopted January 31, 1962, of the ordinances of the City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
