The last known name and address of each owner as shown on the records of the County Assessor may be used for this notice.

The notice shall briefly describe the boundaries of the proposed Planned District and shall state that the Planning Commission, at the conclusion of the hearing, reserves the right to make any of the following findings to the City Council:

- 1. That all or any portion of the property be placed in a Planned District and that appropriate development controls be made applicable to the said property.
- That none of the property be placed in a Planned District.
