AN ORDINANCE INCORPORATING A PORTION OF A PARTITION OF PUEBLO LOT 219, MAP NO. 841 AND A PORTION OF LOT 47, BAY CREST, MAP NO. 5334, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 31 (NEW SERIES), ADOPTED SEPTEMBER 6, 1932 AND ORDINANCE NO. 8717 (NEW SERIES), ADOPTED AUGUST 30, 1962, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, BY THE Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance, a parcel map or maps is recorded on a portion of a partition of Pueblo Lot 219, Map No. 841 and a portion of Lot 47, Bay Crest, Map No. 5334, in the City of San Diego, California, designated "R-3" on Zone Map Drawing No. B-3045, the provisions of Section 101.0411 of the San Diego Municipal Code shall attach and become applicable to the said land and the said land shall be incorporated into R-3 Zone, as described by Section 101.0411, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3045, filed in the office of the City Clerk as Document No. 762768. Said zoning shall attach only to those areas included in the parcel map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 31 (New Series), adopted

September 6, 1932 and Ordinance No. 8717 (New Series), adopted August 30, 1962, of the ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
