AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6 OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 86.09.3 RELATING TO PARKING OR STANDING IN CONSULAR PARKING ZONES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6 of the San Diego Municipal Code be amended by adding Section 86.09.3 to read as follows:

SEC. 86.09.3 PARKING OR STANDING IN CONSULAR PARKING ZONES

No person shall stop or stand any vehicle in a

"Consular Parking Zone" unless the person is a consular

officer or employee in a consulate and the vehicle displays
a distinguishing consular license plate.

Consular Parking Zones shall be operative twenty-four (24) hours a day (Sundays and holidays included); provided, however, that the City Manager may determine and declare limited periods during which any "Consular Parking Zone" shall be operative, and such limited operative period shall be effective when appropriate signs giving notice thereof are erected.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
