AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.06 RELATING TO PARKING, STANDING, LOADING ZONES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6 of the San Diego Municipal Code be amended by amending Section 86.06 to read as follows:

SEC. 86.06 PARKING, STANDING, LOADING ZONES

The City Manager is hereby authorized to determine the location of Loading Zones, Passenger Loading Zones, Bus Loading Zones, Taxi Zones, prohibited Standing or Parking Zones, Safety Zones, Disabled Persons Parking Zones, Alley Parking Zones, and Consular Parking Zones. Such zones shall be effective when appropriate signs or curb markings giving notice thereof are erected upon such zones.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
