AN ORDINANCE PREZONING LOT 53, RANCHO MISSION; PORTIONS OF LOTS 61, 62 AND 63, RANCHO MISSION; PORTION OF LOT E, PARTITION OF PORTION OF LOT 70, RANCHO MISSION; AND PORTION OF LOT 46, ROSEDALE TRACT (APPROXIMATELY 270 ACRES), LOCATED ON THE NORTH SIDE OF MISSION GORGE ROAD BETWEEN OLD CLIFFS ROAD AND MARGERUM AVENUE IN THE NAVAJO COMMUNITY PLAN AREA, (COUNTY-ANNEXATION), IN THE COUNTY OF SAN DIEGO, CALIFORNIA INTO A-1-10 AS DEFINED BY SECTION 101.0404 AND M-1B ZONE AS DEFINED BY SECTION 101.0435.2, OF THE SAN DIEGO MUNICIPAL CODE.

No. C-636, filed in the office of the City Clerk under Document
No. 763856 be, upon annexation to The City of San Diego, incorporated
into A-1-10 Zone as defined by Section 101.0404 and M-1B Zone as
defined by Section 101.0435.2 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, or the effective date of County-Annexation, whichever is later.
