AN ORDINANCE INCORPORATING LOT 53, RANCHO MISSION; PORTIONS OF LOTS 61, 62 AND 63, RANCHO MISSION; PORTION OF LOT E, PARTITION OF PORTION OF LOT 70, RANCHO MISSION; AND PORTION OF LOT 46, ROSEDALE TRACT (APPROXIMATELY 270 ACRES), LOCATED ON THE NORTH SIDE OF MISSION GORGE ROAD BETWEEN OLD CLIFFS ROAD AND MARGERUM AVENUE IN THE NAVAJO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B, AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 7905 (NEW SERIES), ADOPTED JUNE 12, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 53, Rancho Mission; portions of
Lots 61, 62 and 63, Rancho Mission; portion of Lot E, partition
of portion of Lot 70, Rnacho Mission; and portion of Lot 46,
Rosedale Tract (approximately 270 acres), located on the north
side of Mission Gorge Road between Old Cliffs Road and Margerum
Avenue in the Navajo Community Plan Area, in the City of San
Diego, California, within the boundary of the district designated
"M-1B" on Zone Map Drawing No. C-636, be, and it is hereby
incorporated into M-1B Zone, as such zone is described and
defined by Section 101.0435.2 of the San Diego Municipal Code.

Section 2. That Ordinance No. 7905 (New Series), adopted June 12, 1958, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions

of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
