

AN ORDINANCE INCORPORATING A PORTION OF SOUTHWEST 1/4, NORTHWEST 1/4, SECTION 36, TOWNSHIP 18 SOUTH, RANGE 2 WEST, S.B.B.M., RECORD OF SURVEY 7703 (APPROXIMATELY 7,666 SQUARE FEET), LOCATED ON THE NORTH SIDE OF AVENIDO DE LA MADRID BETWEEN CAMINO DE LAS SONRISAS AND CAMINO ESPERANZA, IN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10862 (NEW SERIES), ADOPTED JUNE 29, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HERewith.


BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a portion of Southwest 1/4, Northwest 1/4, Section 36, Township 18 South, Range 2 West, S.B.B.M., Record of Survey 7702 (approximately 7,666 square feet), located on the north side of Avenida de la Madrid between Camino de las Sonrisas and Camino Esperanza, in the San Ysidro Community Plan Area, in the City of San Diego, California, with the boundary of the district designated "R-2" on Zone Map Drawing No. B-3110, is the subject of which a parcel map or maps is submitted to the City and thereafter recorded, and provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0409 of the San Diego Municipal Code shall attach and become applicable to said land, and said land shall be incorporated into R-2 Zone, as described and defined by Section 101.0409, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3110, filed in the office of the City Clerk as Document No. 763922. Said zoning shall attach only to those areas included in the parcel map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 10862 (New Series), adopted June 29, 1972, of the ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance..
