AN ORDINANCE AMENDING ORDINANCE NO. 12360 (NEW SERIES) ENTITLED, "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1978-79."

WHEREAS, Emergency Ordinance No. 12384 (New Series), adopted June 29, 1978 amended salary Ordinance No. 12360 (New Series) to delete salary increases provided in said salary ordinance; and

WHEREAS, such action was accomplished by rescinding Exhibit "A" to Ordinance No. 12360 (New Series) and substituting in lieu thereof, a revised base salary table as Revised Exhibit "A" to Emergency Ordinance No. 12384 (New Series); and

WHEREAS, the emergency nature of the process and the narrow time frame within which action was required caused an administrative omission in said Emergency Ordinance; and

WHEREAS, said omission was the accompanying rescission of Exhibit "C" to salary Ordinance No. 12360 (New Series), said exhibit entitled "Unclassified Service" and the substitution in lieu thereof of a revised Exhibit "C"; and

WHEREAS, such action is corrective only and is deemed necessary at this time to properly reflect the intent of the legislative body; and

WHEREAS, said corrective action requires an amendment to Ordinance No. 12360 (New Series), as amended; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Ordinance No. 12360 (New Series), as amended, entitled, "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1978-79," be and the same is hereby further amended by rescinding Exhibit "C" thereto, entitled, "Unclassified Service" and, in lieu thereof, substituting and adding to Ordinance No. 12360 (New Series), as amended, a revised table entitled, "Unclassified Service" (as Revised Exhibit "C"), attached hereto and on file in the Office of the City Clerk as Document No. 764292.

Section 2. All other provisions of Ordinance No. 12360 (New Series), as amended, shall remain in full force and effect.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
