AN ORDINANCE AMENDING CHAPTER III, ARTICLE 1,
OF THE SAN DIEGO MUNICIPAL CODE, BY AMENDING
SECTION 31.0348 RELATING TO LICENSE TAX--
AUTOMOBILES FOR HIRE.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:


Section 1. That Chapter III, Article 1, of the San Diego
Municipal Code be and it is hereby amended by amending Section
31.0348, to read as follows:

SEC. 31.0348 LICENSE TAX - AUTOMOBILES FOR HIRE

Every person engaged in the occupation, whether
as owner or not, of driving any automobile for hire,
sightseeing vehicle, or jitney service vehicle, shall
pay a license tax of fifteen dollars (\$15) per year
or any fraction thereof.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
