Section 1. That that portion of Pueblo Lot 1232, which is more particularly described in Attachment A hereto which is by this reference incorporated herein, is hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named LINDBERGH PARK.

Section 3. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the Recorder of San Diego County a certified copy of this ordinance.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

LEGAL DESCRIPTION

That part of that portion of Pueblo Lot 1232 of the Pueblo Lands of San Diego shown on Miscellaneous Map No. 36 filed November 14, 1921, in the Office of the Recorder of San Diego County, as a copy of the Map made by James Pascoe in 1870, as said portion is described in Parcel 1 of deed to the State of California recorded August 20, 1969, File No. 151807 of San Diego County Official Records, lying Southwesterly of the Southwesterly right-of-way line of State Freeway 11-SD-805-21.6, said part hereby conveyed described as follows:

Beginning at a two inch iron pipe with tag marked "L.S. 2876", set for the Northeast corner of Vista Mesa Annex Unit No. 8, according to Map No. 4356 filed September 17, 1959 in the Office of the Recorder of San Diego County; thence along the following numbered courses: (1) along the Northerly boundary line of said Vista Mesa Annex Unit No. 8, North 89°05'18" West, 126.62 feet to the Northeasterly line of Evangelical Lutheran Church according to Map No. 4725 filed February 24, 1961, in the Office of said County Recorder; (2) along last said line North 33°19'58" West, 222.32 feet to said Southwesterly right-of-way line of State Freeway 11-SD-805-21.6; (3) along last said line South 54°25'50" East, 323.16 feet to the Easterly prolongation of said Northerly boundary line of Vista Mesa Annex Unit No. 8; (4) along said Easterly prolongation North 89°05'18" West, 14.10 feet, returning to the Point of Beginning.
