AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN LANDS IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "CLIFFRIDGE PARK."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That that portion of Pueblo Lot 1296, which is more particularly described in Attachment A hereto which is by this reference incorporated herein, is hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the property hereby set aside and dedicated for park and recreational purposes, together with the property dedicated to park and recreational purposes by Ordinance No. 8701 (New Series), adopted August 9, 1962, is hereby named CLIFFRIDGE PARK.

Section 3. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the Recorder of San Diego County a certified copy of this ordinance.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

LEGAL DESCRIPTION
ADDITION TO CLIFFRIDGE PARK

All that portion of Pueblo Lot 1296 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, copy of which Map was filed in the Office of the County Recorder of said County of San Diego, and is known as Miscellaneous Map No. 36, more particularly described as follows:

Commencing at the Southwesterly corner of said Pueblo Lot 1296; thence along the Westerly line of said Pueblo Lot 1296, North 00°46'21" East, 540.00 feet to the Northerly line of that parcel of land dedicated as a public park by Ordinance 8701 (NS) of the San Diego City Council, adopted August 9, 1962, and recorded September 4, 1962, File Page 152447, in the Office of the San Diego County Recorder; thence along the boundary of said public park as follows: South 89°30'15" East, 38.51 feet; South 54°14'55" East, 30.00 feet to a point on the arc of a 165.00 foot radius curve, concave Southeasterly, a radial of said curve bears North 54°14'55" East to said point; thence Northeasterly along the arc of said curve through a central angle of 20°59'35" a distance of 60.46 feet to a point described as "Point X" in deed to the City of San Diego, recorded August 11, 1970, File No. 142572, in the Office of the San Diego County Recorder; thence South 31°06'15" East, 189.58 feet to the TRUE POINT OF BEGINNING; thence continuing South 31°06'15" East, 213.12 feet to the beginning of a 230.00 foot radius curve, concave Northeasterly, to which point a radial of said curve bears South 58°53'46" West; thence South-easterly along the arc of said curve, through a central angle of 21°58'21", a distance of 88.20 feet; thence North 00°42'05" West, 11.76 feet; thence North 88°36'28" West, 4.24 feet; thence North 00°50'39" West, 138.65 feet; thence South 82°41'47" West, 21.01 feet; thence North 64°41'56" West, 73.69 feet; thence North 20°33'55" West, 45.51 feet; thence North 06°30'23" West, 12.18 feet; thence North 86°26'50" West, 41.76 feet; thence North 04°54'25" East, 10.29 feet; thence North 87°44'17" West, 16.82 feet to the TRUE POINT OF BEGINNING.
