AN ORDINANCE INCORPORATING A PORTION OF BLOCK 25, TRACT NO.--2, ENCANTO HEIGHTS, MAP NO. 1100 AS SHOWN ON MAP NO. 2121 AND A PORTION OF WINNETT STREET VACATED (APPROXIMATELY 24,788 SQUARE FEET), LOCATED AT THE NORTHERLY TERMINUS OF WINNETT STREET BETWEEN FEDERAL BOULEVARD AND HIGHWAY 94, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 3142 (NEW SERIES), ADOPTED MARCH 12, 1946, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That a portion of Block 25, Tract No. 2, Encanto Heights, Map No. 1100 as shown on Map No. 2121 and a portion of Winnett Street Vacated (approximately 24,788 square feet), located at the northerly terminus of Winnett Street between Federal Boulevard and Highway 94, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "M-1A" on Zone Map Drawing No. B-3123, be, and it is hereby incorporated into M-1A Zone, as such zone is described and defined by Section 101.0436 of the San Diego Municipal Code.

Section 2. That Ordinance No. 3142 (New Series) adopted March 12, 1946, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no

building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
