AN ORDINANCE INCORPORATING PARCEL 1, PARCEL MAP NO. 5405 AND A PORTION OF VIRGINIA AVENUE CLOSED (APPROXIMATELY 5.7 ACRES), LOCATED ON THE NORTH SIDE OF AVENIDA CAMIONES BETWEEN VIRGINIA AVENUE AND I-5, IN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1 ZONE, AS DEFINED BY SECTION 101.0430.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958 AND ORDINANCE NO. 10862 (NEW SERIES), ADOPTED JUNE 29, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel 1, Parcel Map No. 5405 and a portion of Virginia Avenue Closed (approximately 5.7 acres), located on the north side of Avenida Camiones between Virginia Avenue and I-5, in the San Ysidro Community Plan Area, in the City of San Diego, California with the boundary of the district designated "C-1" on Zone Map Drawing No. B-3127, be, and it is hereby incorporated into C-1 Zone, as such zone is described and defined by Section 101. 0430.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8028 (New Series), adopted December 18, 1958 and Ordinance No. 10862 (New Series), adopted June 29, 1972, of the ordinances of the City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

This ordinance shall take effect and be in Section 3. force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
