BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 3 of the San Diego Municipal Code be and is hereby amended by amending Section 63.02.5 to read as follows:

SEC. 63.02.5 SAME - DEFACING STRUCTURES, DIGGING CAVES IN CLIFF AREAS, ETC., PROHIBITED

To cut, break, deface or injure any building, monument, rock, fountain, cage, pen, fence, bench, hydrant, swing or other structure, apparatus or property, excepting with the permission or under the direction of the City Manager. It is also unlawful to dig caves or other depressions within the cliff areas adjacent to the ocean shoreline without the written permission of the City Manager.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
