AN ORDINANCE INCORPORATING A PORTION OF LOT 5, RANCHO MISSION OF SAN DIEGO, MAP NO. 330, S.C.C. NO. 348 (APPROXIMATELY 1.10 ACRES), LOCATED ON THE SOUTH SIDE OF CAMINO DEL RIO SOUTH BETWEEN WARD ROAD AND I-805, IN THE EAST MISSION VALLEY AREA PLAN, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE, AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11116 (NEW SERIES), ADOPTED SEPTEMBER 6, 1973, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That a portion of Lot 5, Rancho Mission of San Diego, Map No. 330, S.C.C. No. 348 (approximately 1.10 acres), located on the south side of Camino Del Rio South between Ward Road and I-805, in the East Mission Valley Area Plan, in the City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3085.1, be, and it is hereby incorporated into CO Zone as such zone is described and defined by Section 101.0423 of the San Diego Municipal Code.


Section 2. That Ordinance No. 11116 (New Series), adopted September 6, 1973, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the

provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
