AN ORDINANCE INCORPORATING A PORTION OF PARCEL "A" AND ALL OF PARCEL "B", PARCEL MAP NO. 795 AND A PORTION OF LOTS 2 AND 3, PARTITION OF PUEBLO LOT 1209 OF THE PUEBLO LANDS OF SAN DIEGO, S.C.C. NO. 8341, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within 18 months of the effective date of this ordinance a portion of Parcel "A" and all of Parcel "B", Parcel Map No. 795 and a portion of Lots 2 and 3, Partition of Pueblo Lot 1209 of the Pueblo Lands of San Diego, S.C.C. No. 8341, in the City of San Diego, California, designated "R-2A" on Zone Map Drawing No. B-3113, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0410 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into R-2A Zone, as described and defined by Section 101.0410, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3113, filed in the office of the City Clerk as Document No. 763988. Said Zone shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, the following ordinances of The City of San Diego,
