AN ORDINANCE INCORPORATING LOT 2, COLLEGE TERRACE, MAP NO. 4103 AND A PORTION OF LOT 5, LA MESA COLONY, MAP NO. 346 (APPROXIMATELY 1 ACRE), LOCATED ON THE NORTH SIDE OF EL CAJON BOULEVARD BETWEEN COLLEGE AVENUE AND 62ND STREET, IN THE STATE UNIVERSITY AREA PLAN, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO C-1 ZONE, AS DEFINED BY SECTION 101.0430.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13558, ADOPTED ON JULY 5, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lot 2, College Terrace, Map No. 4103 and a portion of Lot 5, La Mesa Colony, Map No. 346 (approximately 1 acre), located on the north side of El Cajon Boulevard between College Avenue and 62nd Street, in the State University Area Plan, in the City of San Diego, California, within the boundary of the district designated "C-1" on Zone Map Drawing No. B-3134, be, and it is hereby incorporated into C-1 Zone, as such zone is described and defined by Section 101.0430.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13558, adopted July 5, 1932, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
