AN ORDINANCE INCORPORATING A PORTION OF THE NORTH 1/2 OF THE NORTHEAST 1/4 OF SECTION 35, TOWNSHIP 18 SOUTH, RANGE 2, WEST, S.B.B.M. (APPROXIMATELY 7.44 ACRES), LOCATED ON THE NORTH SIDE OF PISTOL RANGE ROAD (ROAD SURVEY 154) BETWEEN THE NORTHERLY EXTENSION OF SMYTHE AVENUE AND THE SOUTHERLY EXTENSION OF PICADOR BOULEVARD, IN THE SAN YSIDRO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO SMALL LOT OVERLAY ZONE, AS DEFINED BY SECTION 101.0455 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of the North 1/2 of the Northeast 1/4 of Section 35, Township 18 South, Range 2, West, S.B.B.M. (approximately 7.44 acres), located on the north side of Pistol Range Road (Road Survey 154) between the northerly extension of Picador Boulevard, in the San Ysidro Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "Small Lot Overlay Zone" on Zone Map Drawing No. B-3124, filed in the office of the City Clerk as Document No. 764148, be, and they are hereby incorporated into the Small Lot Overlay Zone, as such zone is described and defined by Section 101.0455 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
