as follows:


Section 1. That all that portion of the East Half of

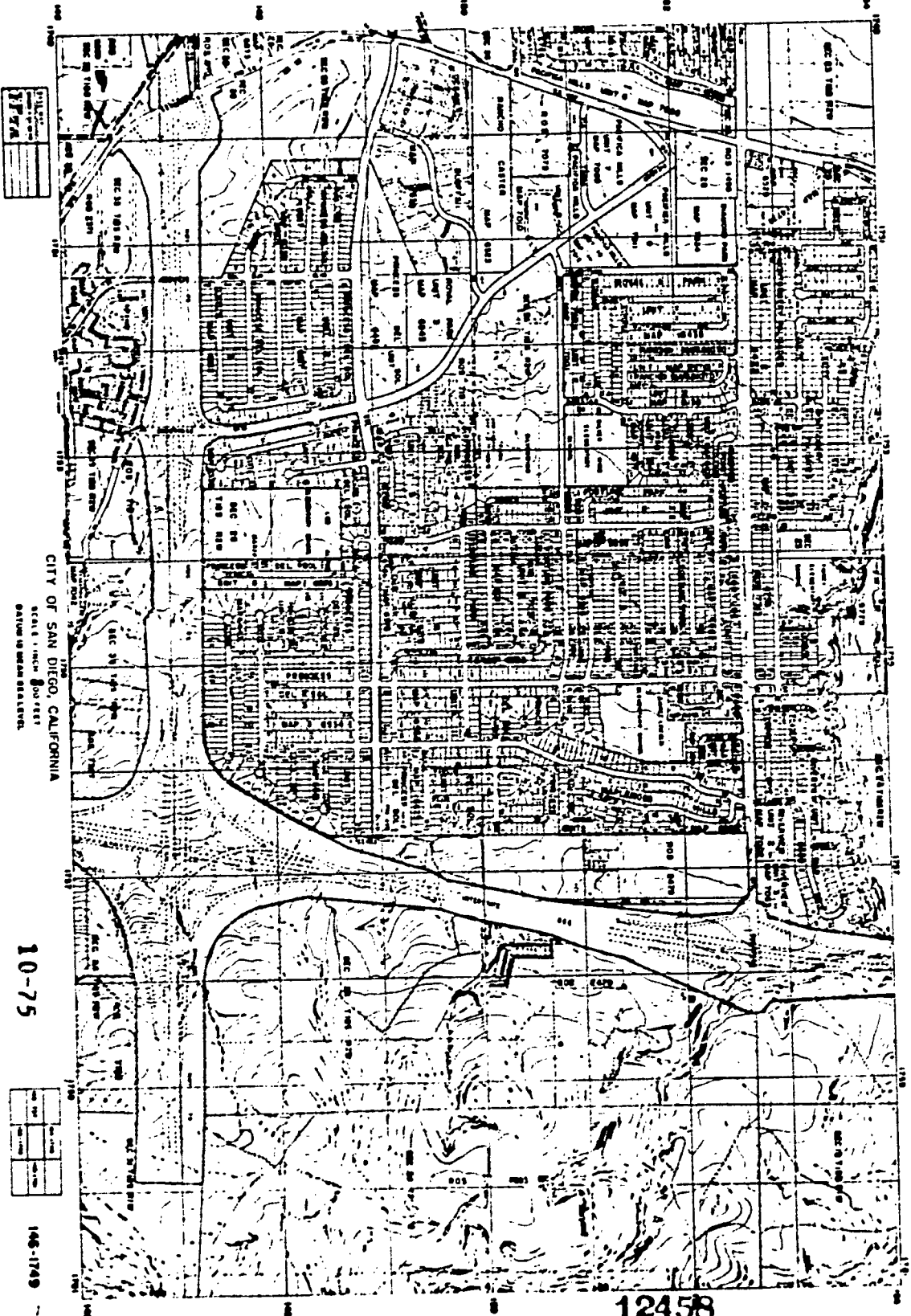


