AN ORDINANCE INCORPORATING A PORTION OF LOT 18, HORTON'S PURCHASE, MAP NO. 283; LOT 2, BROADCAST CITY RESUBIDIVISION NO. 1, MAP NO. 4853; AND RECORD OF SURVEY NO. 811 APPROXIMATELY 2.29 ACRES), LOCATED ON THE WEST SIDE OF 47TH STREET BETWEEN FEDERAL BOULEVARD AND BEECH STREET, IN THE MID-CITY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 35 (NEW SERIES), ADOPTED SEPTEMBER 12, 1932 AND ORDINANCE NO. 11736 (NEW SERIES), ADOPTED DECEMBER 24, 1975, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Lot 18, Horton's Purchase, Map No. 283; Lot 2, Broadcast City Resubdivision No. 1, Map No. 4853; and Record of Survey No. 811 (approximately 2.29 acres), located on the west side of 47th Street between Federal Boulevard and Beech Street, in the Mid-City Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "M-lA" on Zone Map Drawing No. B-3160, be, and it is hereby incorporated into M-lA Zone, as such zone is described and defined by Section 101.0436 of the San Diego Municipal Code.

Section 2. That Ordinance No. 35 (New Series), adopted September 12, 1932 and Ordinance No. 11736 (New Series), adopted December 24, 1975, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no

building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
