AN ORDINANCE INCORPORATING THOSE HILLSIDES EAST OF THE WESTERLY BOUNDARY OF SECTION 34, TOWNSHIP 14 SOUTH, RANGE 3 WEST AND WEST OF AVENIDA DEL GATO, AND BETWEEN LOS PENASQUITOS CANYON ON THE NORTH AND THE SOUTHERLY BOUNDARY OF SECTION 34, TOWNSHIP 14 SOUTH, RANGE 3 WEST ON THE SOUTH, IN THE MIRA MESA COMMUNITY/SCRIPPS RANCH AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO HR (HILLSIDE REVIEW) OVERLAY ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those hillsides east of the westerly boundary of Section 34, Township 14 South, Range 3 West and west of Avenida Del Gato, and between Los Penasquitos Canyon on the north and the southerly boundary of Section 34, Township 14 South, Range 3 West on the south, in the Mira Mesa Community/ Scripps Ranch Area, in the City of San Diego, California, within the boundary of the district designated "HR" on Zone Map Drawing No. C-535.1, filed in the office of the City Clerk as Document No. 761683, be, and they are hereby incorporated into HR Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
